This grant of deviation allows AIR personnel who have not attended FAA Academy Course 22000084 to act as an organization management team (OMT) lead until March 31, 2015

Order 8100.15B, *Organization Designation Authorization Procedures*, paragraph 5-2f(3) requires that OMT leads complete FAA Academy Course 22000084, *Compliance and Enforcement Procedures*. We are aware that the FAA Academy has cancelled offerings of Course 22000084 for Fiscal Year 2013 and 2014 due to changes in policy and training. These cancellations, resulted in some OMT leads not being able to attend the course.

Personnel may act as an OMT lead without having attended Course 22000084 until March 31, 2015. However, these OMT leads must have documentation from their manager identifying another OMT member, who has attended the previous Compliance and Enforcement FAA Academy Course 12020, that can assist in the processing of any ODA holder regulatory violations.
