The purpose of this memorandum is to notify all aircraft certification field offices that we have revised FAA Form 8110-26, Supplemental Type Inspection Report, currently referenced in Order 8110.4C, *Type Certification*. This applies to all field offices responsible for issuing Supplemental Type Certificates (STCs) and those field offices responsible for overseeing Organization Designation Authorization (ODA) holders authorized to issue STCs.

The revisions to this form consist of making it a fillable form and making it Section 508 compliant with the Americans with Disabilities Act (ADA). There were no changes made to the content and data collection requirements of the form.

The revised FAA Form 8110-26 will be referenced in the next major revision of Order 8110.4. In the meantime, it can be obtained electronically at the FAA internal forms library at: https://employees.faa.gov/tools_resources/forms/.
