This approval should not be extended to other rotorcraft of this model on which previously approved modifications are incorporated unless it is determined by the installer that the relationship between this change and any of those other previously approved modifications, including changes in type design, will introduce no adverse effect upon the airworthiness of that rotorcraft. A copy of this certificate and the Instructions for Continued Airworthiness must be maintained as part of the permanent records for the modified rotorcraft.
