These fire extinguisher cartridges are in accordance with the MASS Systems Hermetic Cartridges Kidde Master Drawing List No. 30980, Revision A, dated February 16, 2000, or later FAA approved revisions.

*Limitations and Conditions:* The approval of this change in type design applies to the airplane models noted on the FAA Approved Model List. This approval should not be extended to other specific airplanes of these model series on which other than noted previously approved modifications are incorporated, unless it is determined that the interrelationship between this change and any of those other previously approved modifications will introduce no adverse effect upon the airworthiness of those aircraft.
