Airplane Flight Manual Supplement Number TSI-99-2003, dated 4/13/2000, or later FAA approved revision is required.

OPTION 2 - For aircraft previously modified per STC SA09026SC: Installation of McCauley Propeller Model Number B2A37C238/H-90REA-4.0 in accordance with Texas Skyways, Inc. Drawing Number TSI-99-1003, Revision D, dated 01/17/2000, or later FAA approved revision. Airplane Flight Manual Supplement Number TSI-99-2004, dated 4/13/2000, or later FAA approved revision is required.

*Limitations and Conditions:* For Option 1, installation of SA09133SC is required. For Option 2, installation of SA09026SC is required. Compatibility of this design change with previously approved modifications must be determined by the installer. If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.
