*Description of Type Design Change:* Replace the Lindstrand Balloons Ltd Basket/Burner system with the UltraMagic S.A. Basket Model C-8, S/N C22; UltraMagic S.A. Burner Model MK-21, S/Ns 158, 159, 160. Replace the Lindstrand Balloons Ltd fuel tanks with the UltraMagic S.A. type M-30 fuel tanks, S/Ns 302 and 308 and type M-40 fuel tanks, S/Ns 18 and 19. The UltraMagic S.A. Basket/Burner is installed via the standard Lindstrand Balloons Ltd carabiner (snaplink) attachments.

*Limitations and Conditions:*

1. FAA Approved Balloon Flight Manual Supplement dated December 28, 2009, is required. 2. Maximum Gross Weight is limited to 3,956 lbs. 3. This modified balloon is to be maintained in accordance with the latest revision of the Instructions for Continued Airworthiness (ICA) from Lindstrand Balloons Ltd (Envelope) and UltraMagic, S.A. (Basket, Burner, Fuel Tanks). 4. Descriptive data pertaining to this design change are considered inadequate for duplication in other products. This approval is limited to only the installation made in Lindstrand Balloons Ltd Model 240A, Serial No. 053.

*This certificate and the supporting data which is the basis for approval shall remain in effect until surrendered, suspended, revoked or a termination date is otherwise established by the Administrator of the Federal Aviation Administration.*
