3. Operational approval to use T-PED's must be obtained separately from this STC.
4. FAA STC ST03103CH (T-PED) is required with this STC.
 - a. When installing/activating the GCS on the aircraft the aircraft must comply with the requirements of the above mentioned FAA STC including but not limited to aircraft systems compatibility with RF (Radio Frequencies) effects from T-PED's (Transmitting Portable Electronic Devices).
 - b. No design changes to required aircraft systems may be made without considering the RF (Radio Frequencies) effects from T-PED's (Transmitting Portable Electronic Devices) to the aircraft system per the above mentioned FAA STC or other approved method.
