The Balloonworks (FireFly) Basket/Burner is installed via the standard Balony Kubicek carabiner (snaplink) attachments as specified in the FAA Approved Balloon Flight Manual Supplement dated January xx, 2016.

*Limitations and Conditions:*

1. FAA Approved Balloon Flight Manual Supplement dated February 18, 2016, is required. 2. This modified balloon is to be maintained in accordance with the latest revision of the Instructions for Continued Airworthiness (ICA) from Balony Kubicek (Envelope) and FireFly (Balloon Works) (Basket, Burner, Fuel Tanks) 3. You cannot use descriptive data about this design change to duplicate other products. This approval is limited to only the installation made in Balony Kubicek Model BB34Z, Serial No. 1096. This STC does not permit manufacturing of parts for multiple installations
