  - b) Lycoming Maintenance and Overhaul Manual AEIO-390-A, dated April 2012 or later Transport Canada approved revision.
  - c) Lake Central Air Services Instructions for Continued Airworthiness, Doc. LCA01250-CD, Rev 3, dated February 11, 2016, or later Transport Canada accepted revision; and
  - d) Lake Aircraft Maintenance Manual, Rev. 3, dated January 3, 2003, or later Transport Canada accepted revision.
  - e) For continued airworthiness of the MT Propeller MTV-12-B/LD188-119a to be installed with either MT Propeller spinner assembly P-1005-1 or P-1005, maintain in accordance with MT Propeller Operating and Installation Manual E-124, Rev 56, dated September 15, 2015 or later Transport Canada accepted revision; or
  - f) For continued airworthiness of the MT Propeller MTV-12-B-C-R(M)/CRLD 188-119a, to be installed with MT Propeller P-480 Series Governor and either MT Propeller spinner assembly P-1005-1 or P-1005, maintain in accordance with MT Propeller Operating and Installation Manual E-124, Rev 56, dated September 15, 2015 or latest Transport Canada accepted revision AND MT Propeller Operating and Installation Manual E-508, dated June 12, 2002 or later Transport Canada accepted revision; or
  - g) For continued airworthiness of the Hartzell Propeller BHC-E2YR-1BLFP/FL7894-4, maintain in accordance with Hartzell Overhaul and Maintenance Manual 113B, Rev 42, dated April 2015 or later Transport Canada accepted revision.
  - h) Lake Aircraft Flight Manual Supplement, LCA-01250-FMS, Rev. 3, dated October 26, 2015, or later Transport Canada approved revision.

Limitations and Conditions (continued):

- e) Governor: MT-Propeller Entwicklung GmbH's P-480-( ) Series
