Installation of mounting brackets as provisions for future mechanical installation of Electronic Flight Bag Display Units (DUs) and Remote Processing Units (RPU) in accordance with Electronic Cable Specialists Master Data List ECS-207771, Revision C, dated April 15, 2010, or later FAA approved revision.

Limitations and Conditions:

- 1) Compatibility of this design change with previously approved modifications must be determined by the installer.
- 2) The equipment for which these provisions are intended has not been certified. Additional FAA approval is required for the installation of this equipment, along with an evaluation that includes the items listed within the Flight Deck Evaluation document as listed in Appendix A of Electronic Cable Specialists Master Data List ECS-207771, Revision C, dated April 15, 2010, or later FAA approved revision, to assure satisfactory compliance with applicable airworthiness standards.
- 3) The Airplane Flight Manual Supplement as listed in Appendix A of Electronic Cable Specialists Master Data List, ECS-207771, Revision C, dated April 15, 2010, or later FAA approved revision, is required on board the modified aircraft.
- 4) This modification may not be installed after August 30, 2010, unless (1) previously approved electrical wiring interconnection system (EWIS) instructions for continued airworthiness (ICA) have been evaluated and determined to be adequate for this installation, or (2) revised EWIS ICA have been approved by the FAA Oversight Office. (Refer to § 26.11)
- 5) If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.

This certificate and the supporting data which is the basis for approval shall remain in effect until surrendered, suspended, revoked or a termination date is otherwise established by the Administrator of the Federal Aviation Administration.
