Installation of the STG Aerospace Inc. (SafTGlo Inc.) photoluminescent floor proximity emergency escape path marking system (FPEEPMS) in accordance with STG Aerospace MDL Report Number P12-2, Rev C dated April 23, 2007 or later FAA-Approved revision.

Limitations and Conditions:

The photoluminescent FPEEPMS is only eligible for installation on aircraft model numbers with interior arrangements approved in the STG Aerospace MDL No. P12-2, Rev C dated April 23, 2007 for the Aerospatiale ATR42 incorporating SafTGlo Drawing SG-ATR42 Rev B, dated April 23, 2007, or later FAA-Approved revision and for the Aerospatiale ATR72 incorporating SafTGlo Drawing SG-ATR72 Rev I.R., dated April 23, 2007, or later FAA-Approved revision. Electrically lit door exit marker lighting levels and cabin lighting levels must be measured for acceptability prior to installation in accordance with STG Aerospace Report Nos. P12-12 Rev B dated April 23, 2007, and P12-10 Rev C dated April 23, 2007 or later FAA-Approved revisions. A copy of this Certificate and FAA-Approved Airplane Flight Manual Supplement (AFMS), STG Aerospace Report No. P12-13, Rev B dated April 23, 2007 and Flight Crew Operating Manual (FCOM) Supplement, STG (See continuation page 3 of 3)
