C, dated 6/3/91, or later FAA approved revision.

Limitations and Conditions: This approval should not be incorporated on any certificated product of this model on which other approved modifications are incorporated, unless it is determined that the interrelationship between this change and any of those previously incorporated modifications will not introduce any adverse effect upon the airworthiness of the certificated product.
