The photoluminescent FPEEPMS is only eligible for installation on aircraft model numbers with interior arrangements approved in the SaFTGlo MDL No. L69-2, Rev A dated January 30, 2003 for the Airbus A340 -200 & -300 incorporating SaFTGlo Drawing SG-A340 Rev A, dated January 17, 2003, or later FAA-Approved revision. Electrically lit door exit marker lighting levels and cabin lighting levels must be measured for acceptability prior to installation in accordance with SaFTGlo Report Nos. L69-12 Rev I.R. dated December 12, 2002 and L69-10, Rev I.R. dated December 12, 2002 or later FAA-Approved revisions. A copy of this Certificate and FAA-Approved Airplane Flight Manual Supplement (AFMS), SaFTGlo Report No. L69-11 Rev I.R. dated May 12, 2003, the Flight Attendant Manual Supplement, SaFTGlo Report No. L69-13, Rev I.R. dated December 12, 2002, and Flight Crew Operating Manual (FCOM) Supplement, SaFTGlo Report L69-14 Rev I.R. dated December 12, 2002 or later FAA-Approved revisions are required parts of this STC.
