Description of Type Design Change:

Installation of a cargo door in accordance with Murray Aircraft Modifications, LLC Master Data List, Document Number DC309-1730-00, Revision A, dated August 15, 2008, and Murray Aircraft Modifications, LLC, Engineering Order, Document Number DC309-1730-04, Revision A, dated August 14, 2008; or later FAA approved revisions.

Limitations and Conditions:

1. This STC shall be accomplished only in concert with, or subsequent to STC Number SA02463CH, that modifies the aircraft from a passenger configuration aircraft to an all cargo configuration aircraft, STC Number SA02464CH, that relocates the over wing emergency exit door, STC Number SA02592CH, that installs a pressure bulkhead, and STC SA02593CH that installs a cargo floor.
2. FAA Approved Murray Aircraft Modifications, LLC Aircraft Flight Manual Supplement, Document No. DC309-1730-02, Revision A, dated August 14, 2008, or later FAA approved revision is required.
3. Modified aircraft must be maintained in accordance with Murray Aircraft Modifications, LLC Instructions for Continued Airworthiness, Document No. DC309-1730-03, Revision IR, dated July 14, 2008, or later FAA accepted revision.
4. The installer must determine whether this design change is compatible with previously approved modifications.
5. If the holder agrees to permit another person to use this certificate to alter a product, the holder must give the other person written evidence of that permission.

This certificate and the supporting data which is the basis for approval shall remain in effect until surrendered, suspended, revoked or a termination date is otherwise established by the Administrator of the Federal Aviation Administration.
