Description of Type Design Change: Remove existing 8 across business class seats in the C-Zone and replace them with larger 7 across business seats, reducing the seat count from 392 to 378 and increasing the pitch from 38 inches to 40 inches. This installation is in accordance with United Air Lines DAS-1-WE Approved Drawing List No. 2769 dated December 13, 1989, or later FAA approved revisions.

Limitations and Conditions: This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated unless it is determined by the installer that the interrelationship between this change and any of those previously approved modifications will introduce no adverse effect upon the airworthiness of that aircraft. This determination should include consideration of significant changes in weight distribution such as an increase in the fixed disposable weight in the fuselage. If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.

This certificate and the supporting data which is the basis for approval shall remain in effect until surrendered, suspended, revoked or a termination date is otherwise established by the Administrator of the Federal Aviation Administration.
