(4) A VHF-22C unit can be installed to replace either an existing VHF-22A or VHF-22B unit. A VHF-22D unit can only be installed to replace an existing VHF-22B unit. (5) If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.
