This modification must be maintained in accordance with the Instructions for Continued Airworthiness as described in the documents on Fliegen Works, Inc., Master Drawing List FW420-90-03-CDE, Revision B, dated April 17, 2007, or later FAA-approved revision.

*Limitations and Conditions :* This modification does not provide provisions for installation of electrical wiring. The equipment for which these provisions are intended has not been certified. Additional FAA approval is required for the installation of this equipment and must be evaluated to assure satisfactory compliance with the applicable airworthiness standards.

This approval should not be extended to other aircraft on which other previously approved modifications are incorporated unless it is determined by the installer that the relationship between this change and any of those other previously approved modifications, including changes in type design, will introduce no adverse effect upon the airworthiness of that aircraft. A copy of this certificate and Instructions for Continued Airworthiness must be maintained as part of the permanent records for the modified aircraft.

If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.
