FAA/DAS Approved Supplemental Flight Manual, P/N 891782, dated 8-07-98 is required for Navion Models A, B, D, E, F, G, and H When Modified By Palo Alto Airport, Inc. or Symon's Engineering, Horizontal Stabilizer Angle of Incidence Change and Models A, B, D, E, and F When Modified with STC SA4-915 (Tip Tanks), STC SA4-1121 (Increased Gross Weight) or 285 H.P. Engine Conversion or Any Combination Of The Above or later FAA Approved revisions of the above supplement.
3. FAA/DAS Approved Supplemental Flight Manual, P/N 891782, Revision 1, dated 3-05-02 is required for Navion models A, B, D, E, F, G, and H when modified by Palo Alto Airport, Inc. or Symon's Engineering horizontal stabilizer angle of incidence change with or without tip tanks and the above models when modified by 285 H.P. engine conversion or later FAA Approved revisions of the above supplement.
