Termination of Subscription Service

Civil Aeronautics Manual 1

The Federal Aviation Agency has issued a new Federal Aviation Regulation, Part 21--Certification Procedures for Products and Parts New, to become effective February 1, 1965, which completes the recodification of Civil Aeronautics Manual 1 dated December 15, 1959. With the receipt of this new FAR Part 21, your subscription service to CAM 1 has been completed. However, please note that CAM 1 is not deleted until February 1, 1965, the effective date of Part 21 New.

Other FARs already issued which affect certain sections of Civil Air Regulation/Civil Aeronautics Manual 1 are Parts 39, 45, and 91. Part 39 recodifies only the first sentence of CAR 1.24 (a) and FAR 91 recodifies CAR 1.68 while FAR Parts 21 and 45 recodify the larger portions of CAR/CAM 1.

Changes to these new FAR Parts will be sent free to those who send FAA the order form included in the front of each Part.
