2. Sierra Nevada Corporation Instructions for Continued Airworthiness (ICA), 01610008 Rev. B dated March 1, 2013 or later FAA accepted revision is required for this modification. This ICA is applicable to both Configuration #1 and Configuration #2.
3. FAA Approved Airplane Flight Manual Supplement, Supplement No. 01610017 Rev. A dated 05/29/2013 or later FAA approved revision is required for this modification. This AFMS is applicable to both Configuration #1 and Configuration #2.
4. This approval should not be incorporated in any aircraft of this specific model on which other approved modifications are incorporated, unless it is determined that the interrelationship between this change and any of those previously incorporated approved modification will not introduce any adverse effect upon the airworthiness of the aircraft.
