Description of Type Design Change: The seating capacity of the first class cabin will be increased from 12 to 24 seats (24F/164Y). This modification installs three additional rows of First Class (12 seats total) and removed three rows of Coach (18 seats total) and class divider partitions in accordance with United Air Lines, DAS-1-WE, Approved Drawing List No. 2797 dated November 4, 1991, or later FAA approved revisions.

Limitations and Conditions: The approval of this installation applies basically to the Boeing 757-200 Series only. This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated unless it is determined by the installer that the interrelationship between this change and any of those other previously approved modifications will introduce no adverse effect upon the airworthiness of that aircraft. A copy of this STC must be included in the permanent records of the modified aircraft. If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission
