2. FAA approved Rotorcraft Flight Manual Supplements dated August 2, 1993, or later approved revision is required for either the AS350B, C, D, D1 or AS350BA, B1, B2 models.
3. Paravion Technology, Inc. Report No. PR-350CM-900M, "Camera Mount Installation Instructions" dated May 18, 1993, or later revision is a required part of this installation. (See Continuation Sheet, Page 3 of 3)


