Installation of a passenger interior configuration in accordance with Master Drawing List AA15-2964 Revision A dated January 15, 2016 or later FAA approved drawing revisions.

Limitations and Conditions:

- Passenger interior configurations of 221 passengers or more are only applicable to:
- A321-211, -212, -213, -231, and -232 Series airplanes with large wingtip device (Sharklet Modification 160023) and Modification 157272 (Max Pax), which are eligible for a maximum seating capacity of 230 passengers. The compensating features in ELOS Memo No. AT10407IB-T-CS-2 must be maintained.

This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated, unless it is determined by the installer that the interrelationship between this change and any other previously approved modifications will produce no adverse effect upon the airworthiness of that airplane. If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.
