2. Rotorcraft is to be maintained in accordance with SkyTrac Instructions for Continued Airworthiness ICA14069-1, Revision B, dated January 8, 2016, or later Transport Canada-accepted revision.

Limitations and Conditions:

1. Installation of the ISAT-200A with a lithium battery installed is prohibited.
2. Operation is subject to the limitations set forth in SkyTrac Flight Manual Supplement FMS14069-1, Revision N/C, dated January 15, 2015, Transport Canada approved February 3, 2015, or later Transport Canada-approved revision.
3. The installer must determine whether this design change is compatible with previously approved modifications.
