**Limitations and Conditions Continued:**

Airplane Flight Manual (AFM) Supplement, document number AFM1502-1, Revision 4, dated October 15, 2009, or later FAA approved revision, must be made available to the operator at the time of installation.

Instructions for Continued Airworthiness (ICA), document number ICA1502-1, Revision. B, dated October 5, 2009, or later FAA accepted revision, must be made available to the operator at the time of installation.

ICA document number ICA1502-1 must be revised and resubmitted to the SEA-AEG for acceptance prior to December 17, 2009, to ensure complete instructions for on-wing aircraft maintenance.

This modification may not be installed after August 30, 2010, unless (1) previously approved electrical wiring interconnection system (EWIS) ICA's have been evaluated and determined to be adequate for this installation by the FAA, or (2) revised EWIS ICA have been approved by the FAA oversight office. (Refer to § 26.11)

Supplement Type Certificate (STC) ST01453SE, Installation of tourist class seats in Zone C, must be installed on aircraft serial number 27504, 27505, 27506, 27507, 27508, 27509, 27510, and 33703 prior to installation of this STC.

**Certification Basis:**
