- 2. Beriger Aero Instructions for Continued Airworthiness, Maintenance and Overhaul Manual MM-STC-013, revision 1, dated March 11, 2016 or later EASA accepted revisions is required with this modification.

Limitations and Conditions:

- 1. Only DA 42 models with MTOW equal or less than 1900 kg are eligible for this STC approval (i.e. not on DA 42 models with MAM 42-678 and/or MAM 42-659 modifications installed).
- 2. The installer must determine whether this design change is compatible with previously approved modifications.
