Description of the Type Design Change: Installation of an interior reconfiguration on Boeing Model 777-300 series airplanes in accordance with Jamco America, Inc. Master Drawing List (MDL) No. D1500LS1147-1, Revision S, dated December 17, 2008, or later Federal Aviation Administration (FAA) approved revision.

Limitations and Conditions: Approval of this change in type design applies to the above model aircraft only. This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated unless it is determined that the relationship between this change and any of those other previously approved modifications will introduce no adverse effect upon the airworthiness of the aircraft. A copy of this certificate and Jamco America, Inc. MDL D1500LS1147-1 must be maintained as part of the permanent records for the modified aircraft. Supplemental Type Certificate (STC) No. ST02230NY-D, installation of in-flight entertainment system, and Boeing service bulletin 777-23-0244, installation of video monitor provisions, must be installed concurrently with this modification.
