Description of Type Design Change: Installation of turbulent air tether system consisting of the installation of the tether assembly on Fairchild Hiller Food Service Carts P/Ns 802000, 803000, and 804000 and restraint attach points on U.O.P Aerotherm seats in accordance with FAA Approved United Air Lines Drawing List Number 001 or later FAA approved revisions.

Limitations and Conditions: The approval of this change in type design applies basically to the Boeing DC-10-10 aircraft only. This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated unless it is determined by the installer that the interrelationship between this change and any of those other previously approved modifications will introduce no adverse effect upon the airworthiness of that aircraft. A copy of this STC must be included in the permanent records of the modified aircraft. This determination should include consideration of significant changes in weight distribution such as an increase in the fixed disposable weight in the fuselage. If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.

This certificate and the supporting data which is the basis for approval shall remain in effect until surrendered, suspended, revoked or a termination date is otherwise established by the Administrator of the Federal Aviation Administration.
