Description of the Type Design Change: Installation of a Supplemental Lighting System. Manufactured and installed in accordance with Aviation Specialties Unlimited (ASU) Master Drawing List MDL-S61004-3, Revision A, dated October 22, 2012, or later Federal Aviation Administration (FAA) approved revisions and maintained in accordance with ASU Instructions for Continued Airworthiness ICA-S61004-4, Revision IR, dated September 25, 2012, or later FAA-approved revisions.

Limitations and Conditions: This supplemental type certificate applies to the model listed above and only the specific serial numbers listed on the ASU Master Drawing List MDL-S61004-3, Revision A, dated October 22, 2012, or later FAA-approved revisions. This rotorcraft employs Night Vision Imaging System (NVIS) lighting that has been certified to ensure the aircraft is compatible with night vision goggles (NVG). For this reason, interior and exterior modification that add or change systems that emit or reflect light have the potential to alter or change the NVIS lighting and NVG compatibility. Compatibility of this design with subsequent modifications must be determined by the installer. The determination of compatibility with modifications that emit or reflect light may require a re-evaluation by an FAA aircraft certification office. A copy of this certificate and the FAA-approved Rotorcraft Flight Manual Supplement (RFMS) FMS-S61004-6, Revision IR, approved November 1, 2012, or later FAA-approved revision, must be maintained as part of the permanent records for the modified aircraft.

If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.

This certificate and the supporting data which is the basis for approval shall remain in effect until surrendered, suspended, revoked, or a termination date is otherwise established by the Administrator of the Federal Aviation Administration.
