Description of Type Design Change: Installation of a secondary external load hard point in accordance with FAA approved Aerocraft Inc, Master Data List, ARC-407-MDL, Revision "NC" dated February 22, 2017, and FAA approved Aerocraft+ Rotorcraft Flight Manual Supplement ARC-407HP-RFMS revision "A" dated June 20, 2017 or later FAA Approved Revisions.

Limitations and Conditions: The installation should not be incorporated in any aircraft unless it is determined that the interrelationship between this installation and any previously approved configuration will not introduce any adverse effect upon the airworthiness of the aircraft. The approval of this modification applies to the above noted airplane model series only. This approval is for structural provisions for a 650 pound external load and other aspects of the external loads system have not been certified. Additional FAA approval is required for external loads operations which must be evaluated to assure satisfactory compliance with the applicable airworthiness standards. A copy of this STC must be included in the permanent records of the modified aircraft. If the holder agrees to permit another person to use this certificate to alter the product, the holder shall give the other person written evidence of that permission.
